#### Rabies vaccine 3 yr, DA2LPPV 3 yr, Bordetella Intranasal

- Advised on possible vaccine reactions/side effects and what to expect. For example rashes, facial swelling, local pain/sensitivity, itching, nausea/vomiting, and drowsiness. If you appreciate any facial swelling or difficulty breathing please be sure to contact Catskill Veterinary Services or a nearby emergency veterinarian. If any of the other side effects occur for more than 24 hours please contact us for further evaluation.
- Explained to owner **Bordetella** is a risk-based vaccine; as long as the patient is not boarding and will not be exposed to high-population dog areas such as dog parks, groomers, and boarding facilities there is no need to give the vaccine
- Addressed how to maintain the patient's oral health, including cleaning teeth and eating crunchy foods to reduce plaque buildup. Can brush patient's teeth if the patient would allow it, can do finger brushing or mechanical active brushing for cleaning teeth but do not use human toothpaste
- Recommended running bloodwork to make sure the patient is healthy as well as their systemic functions are working normally **Owner agreed** 
  - Will call once bloodwork result is available; expect a call within a week
- Call if there are any problems or concerns

Please monitor for lethargy, vomiting, diarrhea, increased respiratory rate or effort, or any other symptoms you are concerned with. If this occurs, please call us.
